As a basis for its deliberations, the meeting will have before it the following: document ESCAP/GCM/2021/1, in which the implementation of the Global Compact is assessed, including an overview of key international migration trends and an analysis of the impacts of COVID-19 on international migration, and document ESCAP/GCM/2021/2, in which the interlinkages between the Global Compact and the 2030 Agenda are highlighted. The meeting will also have before it conference room ESCAP/GCM/2021/CRP.1 containing a summary of the results reported from voluntary national reviews of member States on the implementation of the Global Compact and conference room paper ESCAP/GCM/2021/CRP.2 containing a summary of the outcomes of a series of stakeholder consultations on the implementation of the Global Compact.

Meeting participants may wish to share experiences and findings with regard to adopting policies and programmes to achieve the Global Compact. The deliberations under this agenda item are expected to result in enhanced understanding of progress, good practices, challenges and emerging issues associated with the implementation of the Global Compact and the migration-related commitments of the 2030 Agenda, including the challenges posed by the COVID-19 pandemic.

Objective 18: Invest in skills development and facilitate mutual recognition of skills, qualifications and competences

The deliberations under this agenda item are expected to result in a deeper understanding of the progress, good practices, challenges and emerging issues associated with the implementation of the objectives of the Global Compact related to ensuring that migration is voluntary, regular, safe and orderly.

### (b) Protecting migrants through rights-based border governance and border management measures (addressing objectives 4, 8, 9, 10, 11, 13 and 21)

The second round-table discussion will focus on the cluster of objectives outlined in General Assembly resolution 73/326, addressing the following objectives of the Global Compact:

Objective 4: Ensure that all migrants have proof of legal identity and adequate documentation

Objective 8: Save lives and establish coordinated international efforts on missing migrants

Objective 9: Strengthen the transnational response to smuggling of migrants

Objective 10: Prevent, combat and eradicate trafficking in persons in the context of international migration

Objective 11: Manage borders in an integrated, secure and coordinated manner

Objective 13: Use migration detention only as a measure of last resort and work towards alternatives

Objective 21: Cooperate in facilitating safe and dignified return and readmission, as well as sustainable reintegration

The discussion will focus on the cluster of objectives outlined in General Assembly resolution 73/326, addressing the following objectives of the Global Compact:

Objective 1: Collect and utilize accurate and disaggregated data as a basis for evidence-based policies

Objective 3: Provide accurate and timely information at all stages of migration

Objective 7: Address and reduce vulnerabilities in migration

Objective 17: Eliminate all forms of discrimination and promote evidence-based public discourse to shape perceptions of migration

Objective 23: Strengthen international cooperation and global partnerships for safe, orderly and regular migration

The deliberations under this agenda item are expected to result in a deeper understanding of the progress, good practices, challenges and emerging issues associated with the implementation of the objectives of the Global Compact related to strengthening evidence-based policymaking, public debate and cooperation for safe, orderly and regular migration.
