

United Nations Network on Migration Workplan

July 2019

Introduction

The United Nations Network on Migration (Network) has been established to ensure effective, timely and coordinated system-wide support to Member States on migration as they respond to the Global Compact for Safe, Orderly and Regular Migration (GCM). This is an ambitious undertaking on one of the key phenomena facing our international community. Through a more coherent approach to migration governance and to harnessing its contribution to global development, the United Nations system through the Network commits to making a tangible difference to enhancing cooperation on international migration in all its dimensions aimed at making migration work for all.

To date, the Network has focused on putting in place the structures and procedures to enable it to implement its mandate effectively. Principal among these has been outreach to Resident Coordinators and United Nations Country Teams, encouraging their engagement in supporting GCM implementation. The response to this has been encouraging. Also important is the establishment of the Migration Multi-Partner Trust Fund/MPTF (the Start-up Fund). There has likewise been engagement with both Member States and stakeholders, in Geneva, New York, regionally and at country level. The staffing of the Network secretariat has also been a key priority, with welcome secondments from UNHCR, DESA and forthcoming from UNICEF.

With this groundwork in place, this first workplan of the Network focuses on key issues where the UN system can add value in delivering concrete results as a matter of priority in supporting GCM implementation, recognizing that the GCM is rooted in the 2030 Agenda for Sustainable Development. In all it does, the Network will strive to uphold and advocate for the laws and principles which call for the respect and protection of all migrants and their communities, and the realization of all their human rights, with a particular focus on those in the most vulnerable situations.

The workplan comprises three elements: (i) core; (ii) thematic; and (iii) a pipeline of potential future activities. Under the first two, the workplan delineates a number of workstreams focusing on concrete deliverables. The workplan does not purport to be a comprehensive compendium of what the UN system is doing on migration but rather offers an overview of the range of activities in which the Network will engage.

While this workplan represents the commitment of the UN system to ensure effective and coherent system-wide support on migration, it explicitly recognizes that the Network does not operate in a vacuum. Throughout, it privileges partnerships both within the system, including with the new Resident Coordinator system, with Member States, and with other stakeholders, including civil society.

Similarly, the workplan also recognizes the considerable work that has already been undertaken, and is ongoing, and expertise acquired in pursuit of realizing all 23 GCM objectives by a broad range of stakeholders. In implementing this workplan, the Network will prioritize building on and, working with existing expertise and best practice, in support of Member States. Equally, it will prioritize flexibility and

the ability to adapt to changing conditions and demands, not least the needs and aspirations of migrants themselves.

Finally, the workplan also recognizes the importance of addressing migration-related aspects of mixed movements in various situations as well as of ensuring complementarity between the Global Compact on Migration and the Global Compact on Refugees in responding to complex migratory flows.

1: Core priorities

Core priorities are so-called because they constitute the structural building blocks, either directly called for by the GCM or directly flowing from that text, which are essential for the Network to be in a position to provide the necessary support to Member States. They focus on (i) developing the three elements of the capacity building mechanism (CBM); (ii) providing support for strengthening country and regional level United Nations migration coordination mechanisms and supporting country level implementation of the GCM through a more effective integration of migration-related issues into the design and implementation of UN Sustainable Development Cooperation Frameworks (UNSDCFs); (iii) supporting the development of GCM national implementation plans, where requested; (iv) developing the Network's voice; (v) supporting institutional processes including the Secretary-General's report to the General Assembly on the GCM; (vi) supporting negotiations on the modalities for the International Migration Review Forum (IMRF); and (vii) review of working arrangements and preparation of the Network annual meeting. The CBM is discussed separately, below.

Priorities (ii) and (iii) are core to the work of the Network. They highlight the centrality of country and regional-level action in support of the effective implementation of the GCM's objectives, in line with specific priorities identified by Member States, with the support of the United Nations system. To the extent that the workplan of the Network will be demand driven, it is through these priorities that such demand will be generated and where impact will be most quickly felt. And it will be through these priorities, in particular, that the value of the Migration MPTF will be realized. A list of United Nations system country and regional teams with migration coordination mechanisms in place or being established is attached to this workplan as an annex.

Where appropriate, the Network will speak with one voice on migration issues, either in response to pressing developments which call for urgent steps towards resolution, or in addressing complex structural or policy challenges in the field. Priority (v) reflects that undertaking and will be factored into all workstreams, as relevant.

2: Thematic priorities

The GCM contains 23 objectives, designed to ensure a 360-degree approach, underpinned by its overarching guiding principles. To facilitate its implementation, this workplan sets out five thematic areas pooling these objectives together and structured so as to promote United Nations system collaboration. To ensure a coherent approach, they are the same clusters as for the Migration MPTF. The five areas are: (i) Promoting fact-based and data driven migration discourse, policy and planning; (ii) Protecting safety and wellbeing of migrants, including through addressing the drivers and mitigating situations of vulnerability in migration; (iii) Addressing irregular migration including through managing borders and combatting transnational crime; (iv) Facilitating regular migration, decent work and enhancing the positive development effects of human mobility; and, (v) Improving the social inclusion and integration of migrants.

Specific workstreams have been identified as being ripe for the development of tools that will support the operational rollout of the GCM from a thematic perspective. While core priorities will provide the mechanisms to respond to the demands at the country and regional levels in a timely manner, the thematic

priorities will focus on major migration thematic issues that require the development of guidance drawing from strong inter-agency expertise.

The workstreams are not suggestive of a belief that they represent all that needs to be done – or is being done already – in their respective areas: rather they reflect a determination that these constitute important, time-bound contributions towards the realization of particular objectives of the GCM. Additional workstreams may be added as they are identified, and as capacities to effectively support them are realized.

3: Future activities

This annex outlines a number of potential activities that the Network could turn to as capacity increases and/or current taskings are completed. This can be added to (and revised) on an ongoing basis. It is a compendium of proposals of the types of support the Network can provide – to stimulate requests or which can be adapted to particular needs – and which can feed into the development of new workstreams as others are completed or as capacity expands.

Working Groups

For some of the core and thematic workstreams identified, the Network will establish working groups, where relevant, drawing on relevant expertise and capacity, to ensure their delivery. These working groups will focus on concrete, time-bound deliverables against which impact can be measured. They will provide technical advice and inputs as needed and feed into the three elements of the CBM. As with all aspects of the Network's activities, these groups will privilege close collaboration with Member States and stakeholders.

Upon establishment, every working group will develop a workplan with measurable outputs and a timeline for their delivery.

Capacity building mechanism

The GCM calls for the establishment of a capacity building mechanism in the United Nations, building upon existing initiatives, that supports efforts of Member States to implement the GCM. The CBM comprises a Start-up Fund (Migration MPTF), Connection Hub and Global Knowledge Platform. It emphasizes the need to draw on the technical, financial, and human resources, on a voluntary basis, of Member States, the United Nations system and all stakeholders in order to strengthen capacities and foster multi-partner cooperation.

Start-up Fund (Migration MPTF)

The Fund, established by the Network on 8 May 2019, is a United Nations pooled financing mechanism. In its design it privileges programmes which bring together the United Nations system and which are fully aligned with the Agenda 2030 for Sustainable Development. As the United Nations system begins implementing this workplan and engages with Member States and stakeholders in identifying priority areas of work under each of the five thematic areas of the Fund, consideration can be given to designing programmes for potential financing. Pre-identifying such activities will further assist the Migration MPTF Steering Committee in increasing donors' interest in supporting this important component of the GCM and in adopting a comprehensive approach when financing migration related programmes.

ii. Global Knowledge Platform and Connection Hub

The Global Knowledge Platform and Connection Hub are vital elements of the GCM to ensure that relevant knowledge, experience and expertise can be drawn from in developing tailor-made solutions in response to Member State requests.

Critically, experience in implementing the GCM should inform both the Platform and the Hub to ensure that the 'state of knowledge' is constantly refined. The terms of reference of the Migration MPTF call for integrating these elements in the design of funding proposals.

The Network is committed to developing the Platform and the Hub as building blocks for the other workstreams, and to support the working groups, by collating migration evidence, migration policies and practices from existing expertise. Each workstream will inform the Platform and Hub on a continuous basis, emphasizing national and regional experiences.

As a priority, the Network will articulate further details of the Platform and Hub.

Review and Accountability

The Network will conduct its work in line with the principles of the GCM and guided by, inter alia, the United Nations Charter, international law and the Agenda 2030 for Sustainable Development.

The Secretary-General's biennial reporting to the General Assembly will be central for the Network to account for its activities. Annual meetings of the full Network, including relevant stakeholders, will review progress, explore ways to enhance collaboration, and identify emerging issues for consideration in subsequent iterations of the workplan.

The Network, through its Executive Committee, will continually review the implementation of the workplan, adjust its focus as needs arise, and provide regular updates on progress being made.

Core priorities

1. Establishment of a Capacity-Building Mechanism (CBM)

The CBM will build on existing knowledge and initiatives by Member States, the UN and all other relevant stakeholders to support states' efforts to implement the GCM, including through fostering multi-partner cooperation.

The CBM will consist of a Connection Hub, a Global Knowledge Platform and a Start-up Fund. The Start-Up Fund (Migration MPTF) will be instrumental in enabling and testing joint project-oriented solutions. The Connection Hub and Global Knowledge Platform of the CBM will ensure the design of demand-driven and tailor-made solutions to respond to migration realities drawing from a user-friendly open data source platform of existing evidence, practices and initiatives.

3. Speaking with one voice

The Network's Terms of Reference highlight the need to provide leadership to mobilize coordinated and collaborative action on migration by the UN system, including by speaking with one voice as appropriate.

Ensuring that the UN speaks with one voice on migration entails both responding to critical developments in a timely fashion and providing clear long-term guidance on overarching phenomena. It embraces both public commentary and also more collective positions to adopt.
