- Suggestions for leveraging of the UNNM in GCM implementation in Türkiye.

UN Agencies parties to the Network will have the opportunity to share their priorities vis-à-vis the GCM objectives.

Background:

The UN Network on Migration in Türkiye was established by the UN Country Team to support GCM implementation and protect migrants' rights. It aims to enhance understanding of migration, offer policy guidance, and coordinate UN efforts. The network closely collaborates with three key Turkish government entities: Ministry of Foreign Affairs, Presidency of Migration Management, and Directorate General of International Labor Force while aligning with international norms.

Comprising various UN agencies, the network operates under the coordination of the UN Resident Coordinator, convening annually to make decisions through consensus. Its overarching aim is to comprehensively manage migration and protect migrants' rights in Turkey within the framework of international standards.

The UNNM Türkiye Meeting aims to foster collaboration, enhance policy formulation, and promote dialogue between UN agencies and Turkish government entities to address migration challenges effectively while upholding migrants' rights and international standards.
