











Global Online Peer Learning Exchange

Working to End Child Detention in the Context of International Migration

Wednesday, 24 May 2023, 14:30 - 17:30 (CET)

Concept Note

Closed meeting

This GCM Talk, in the form of a peer learning exchange among governments, is cohosted by the UN Network on Migration Workstream on Alternatives to Immigration Detention and the Permanent Missions of Colombia, Portugal and Thailand in Geneva. This exchange will be held under the Chatham House Rule and participation is limited to governmental actors from different levels and to members of the Workstream.

Rationale

Following on from the three global peer learning exchanges held in 2020, 2021, and 2022, the fourth global online peer learning exchange ('GCM Talk for Member States') will be held on 24 May with a particular focus on working to end child immigration detention. This event will provide an opportunity to further realize the commitments made in the International Migration Review Forum (IMRF) Progress Declaration and to consider progress and challenges in working to end the practice of child detention in the context of international migration.

This online meeting will bring together governments from all regions and will provide an open space to discuss experiences with regard to the implementation of Objective 13 of the Global Compact for Safe, Orderly and Regular Migration (GCM) with a focus on children, sharing challenges and concerns, identifying promising practices, and exploring opportunities for continued multi-stakeholder cooperation and whole-of-government approaches.

This GCM Talk for Member States will benefit from the participation of government officials working on developing regional, national and sub-national peer learning platforms.

The **first panel** will focus on the lessons learned from previous peer learning exchanges on ending child immigration detention – with presentations from the Asia Pacific Regional Peer Learning Platform, as well as from the Middle East and North Africa. Participants will also present on cross-regional and sub-national peer learning

exchanges while discussing the existing opportunities to organize such exchanges at different levels in the future.

The **second panel** will focus on sub-national and local level actions that support community-based reception and care of children and families as an alternative to detention. The United Cities and Local Governments (UCLG) will provide an overview of the relevant commitments in the <u>Lampedusa Charter</u> to promote alternatives to detention and enhance care, particularly for children and youth, and of local-level actions that support child-sensitive reception and care practices and children's and families' engagement with the national government systems that will resolve their migration status. Examples of sub-national promising practices will be provided by officials from the US State of California and the Regional Government of Catalonia in Spain.

This GCM Talk will also benefit from the participation of youth advocates, coordinated by the Migration Youth and Children Platform (MYCP) who will provide their perspective on the issue – on the impacts it has had on their lives and the lives of their families and communities, and report on their recommendations. The youth engagement with this peer learning exchange will draw from the GCM Youth Talk "Global Youth Consultation on Ending Child Immigration Detention" taking place on 8 May 2023.

The **third panel** will focus on the next steps to end child immigration detention. This session will provide an opportunity to discuss the appropriate mechanisms for considering progress and challenges on this issue, turning this commitment in the IMRF Progress Declaration into practice. Presentations will focus on identifying upcoming opportunities— such as the development of GCM indicators, establishing peer learning exchanges or platforms at different levels; promoting the implementation and evaluation of existing pledges and encouraging additional pledges and actions in the lead-up to the GCM Regional Reviews; and seeking complementarity of both GCM and GCR pledges in the run-up to the Global Refugee Forum, in December 2023.

States that have recently taken steps forward to end child immigration detention or that are planning to do so will present in this session, including the Government of Colombia, which pledged at the IMRF to provide leadership and collaboration with other States and stakeholders for the global promotion, development and facilitation of spaces for exchange and peer learning on alternatives to immigration detention and ending immigration detention of children.

The UN Migration Network Workstream on Alternatives to Detention aims to provide technical assistance to States to facilitate the practical application of non-custodial community-based alternatives to immigration detention that are in line with international law, respect the human rights of migrants and respond to the migration governance needs of governments.

In 2022, the Workstream produced four snapshots of promising practices on: <u>Ending child immigration detention</u>; <u>Scaling-up community-based alternatives to immigration detention</u>; <u>Temporary regularisation programmes</u>; and <u>Whole-of-government and whole-of-society approaches</u>.
