









# Human Mobility, Disasters, and Climate Change in the IGAD Region: Lessons Learned and Strengthened Partnerships

### **Background**

From 2021-2023, IGAD, IOM, ILO PDD (hosted by UNOPS) and UNHCR together with IGAD and the IGAD Climate Prediction & Applications Centre (ICPAC) launched a first Joint Programme to contribute to facilitating pathways for regular migration in the IGAD region and minimizing displacement risk as well as assessing protection frameworks and the protection environment in the context of climate change, environmental degradation and disasters in line with the vision and guiding principles of the Global Compact for Safe, Orderly and Regular Migration (GCM). It was funded by the Migration Multi-Partner Trust Fund.

The programme enhanced coherent implementation of global frameworks including the GCM; promoted regional approaches and partnerships and increased knowledge on human mobility in the context of climate change; helped create decent green jobs for affected communities and promoted inclusive approaches to disaster risk reduction.

It also offered proof of concept for its activities related to human mobility, disasters, and climate change in the IGAD region. Many of these initiatives show promise for scaling up if future interventions incorporate lessons learned and best practices from this experience. There is also a demand to build and replicate these approaches across the region and beyond, including in the follow-up to the Kampala Ministerial Declaration on Environment and Climate Change (KDMECC).

This event will therefore aim to bring together key partners from this joint programme to reflect upon lessons learned and highlight potential ways forward, including a plan to expand the joint programme in a second phase to further facilitate regular migration and minimize displacement risk in the context of climate change, environmental degradation and disasters. This includes identifying potential new funding structures to support the next phase of implementation.
