# **OVERVIEW**

The Regional Review for Latin America and the Caribbean of the Global Compact for Safe, Orderly and Regular Migration was held from 26 to 28 April 2021, co-organized by the International Organization for Migration (IOM), in its capacity as Coordinator of the United Nations Network on Migration, and the Economic Commission for Latin America and the Caribbean (ECLAC) (see https://pactomigracion.cepal.org/en).

The agencies, funds and programs that integrate the Regional Network on Migration in Latin America and the Caribbean participated in the high-level meeting, together with ministers, deputy ministers and senior officials from 29 ECLAC member States and three associate members, as well as representatives of intergovernmental organizations, the United Nations System, civil society, and other stakeholders.

The Regional Review Meeting on the implementation of the Global Compact for Safe, Orderly and Regular Migration in Latin America and the Caribbean was inaugurated by Alicia Bárcena, Executive Secretary of ECLAC; António Vitorino, Director General of IOM, and Felipe González, United Nations Special Rapporteur on the Human Rights of Migrants.

Representatives from civil society and other stakeholders included Nancy Perez from the Major Group for Children and Youth, and Berenice Valdés, Representative of the Latin-American Bloc.

During the meeting, representatives of the Latin American and Caribbean countries reiterated their commitment to the implementation of the Global Compact on Migration and called for viewing migration as a contribution to democracy, diversity, and sustainable development, respecting, protecting and ensuring migrants' rights and supporting them in vulnerable situations.

Government representatives also committed to implementing the Global Compact on Migration and ensuring that migration is a choice rather than an obligation.

The results of this meeting will constitute an important input for the preparation of the final report that Latin America and the Caribbean will submit to the International Migration Review Forum in 2022.

### MAIN CONCLUSIONS

- Governments in the region reaffirmed the importance they assign to the **Global Compact** for Migration as a multilateral instrument for contemporary migration governance.
- Throughout the round tables, as well as in the debate, it was highlighted that the COVID-19 pandemic has disproportionately affected migrants, aggravating structural inequalities in an already very unequal region. It was also noted that migration is an opportunity for economic recovery and sustainable development.
- The importance of rights, gender, and child-sensitive approaches was reaffirmed, along with whole-of-society and whole-of-government approaches, as well as other guiding principles of the

- Global Compact for Migration. They also underlined the need strengthen international cooperation and produce high-quality data to combat xenophobia and improve evidence-based policymaking. The exchange of perspectives, experiences and good practices was very well received.
- The Regional Review in Latin America and the Caribbean represents a crucial first step on a long road to safe, orderly and regular migration and towards the first International Migration Review Forum to be held in 2022.
- The Regional Review meeting has created expectations for continued engagement and interaction among and with all stakeholders.
