### **Global Stakeholder Consultation on the second round of Regional Reviews of the Global Compact for Safe, Orderly and Regular Migration**

Tuesday, 31 October 2023 / 15:00-16:30 CET  
Wednesday, 1 November 2023 / 9:00-10:30 CET  
*Zoom online platform*

## OVERVIEW

The UN Network on Migration hosted two Global Stakeholder Consultations on the second round of Regional Reviews of the Global Compact for Safe, Orderly and Regular Migration on 31 October 2023 for the African, European, Latin-American and Caribbean regions, and on 1 November 2023 for the Asia-Pacific and Middle East-North Africa regions.

The purpose of these meetings was to provide space for discussion and information-sharing between the UN Network on Migration and stakeholders on plans and roadmaps for [the second round of Regional Reviews](#) of the Global Compact for Migration (GCM).

These consultations were attended by a total of 404 stakeholders representing diverse sectors, including migrants, civil society, migrant and diaspora organizations, faith-based organizations, local authorities and communities, the private sector, trade unions, parliamentarians, National Human Rights Institutions, the International Red Cross and Red Crescent Movement, academia, media, and other groups, representing all categories of stakeholders identified in the GCM ([para 44](#)). Additionally, members of the Network also participated in these consultations, including regional Network members who gave presentations on respective roadmaps and plans known thus far.

This report outlines key points raised during the meeting concerning the plans and roadmaps for the forthcoming 2024-2025 Regional Review of the Global Compact for Migration (GCM) and the ways stakeholders can engage in the preparatory processes and activities.

## I. REGIONAL REVIEWS 2024–2025

### *Framework for the second round of Regional Reviews*

- A proposed note outlining the framework for the second round of Regional Reviews of the Global Compact for Safe, Orderly and Regular Migration (GCM) is available [here](#).
- The second round of Regional Reviews provides an opportunity to Member States and stakeholders to review the implementation of the GCM within their respective regions, including as regards the actions set out in the Progress Declaration and to formulate critical findings and recommendations to inform the 2026 IMRF.

- For the second round of the GCM Regional Review, voluntary national reports by Member States will not be requested. Instead, Member States, stakeholders, and Network members may co-organize “GCM Talks” and other preparatory consultations may be co-organized by Member States, stakeholders, and Network members as peer-learning exchanges to continue discussions on how best to implement the GCM and to highlight sector-specific or thematic priorities.
- The UN Network on Migration will offer support to each subregional, regional and cross-regional process, platform and organization in the preparation and organization of their review.
- Serving as the culmination of these discussions, the UN Regional Economic Commissions (RECs), supported by and being members of the UN Network on Migration, will each organize a Review meeting for their respective Member States. In addition, the Network will organize one multi-stakeholder consultation for each of the five regions, contributing to the meetings of the respective regional commissions.
- All meetings and dialogues making up the Regional Reviews will result in a summary report that will be shared with the Coordinator of the Network, including for incorporation into the next Secretary-General’s report due in 2024 and any subsequent reporting.
- To effectively inform the next IMRF, the Coordinator of the Network will ensure that these reports are submitted to the President of the General Assembly. Additionally, these reports, along with national reports that Member States will be preparing in 2025, will be forwarded to the co-facilitators of the IMRF Progress Declaration in 2026. This process aims to ensure that both regional and national perspectives are represented at the global level.

***Stakeholder Roadmap for the Regional Reviews: entry points for civil society and stakeholders***

- The preparatory process of the Regional Reviews has been designed to collectively set an ambitious agenda and enable multiple entry points for meaningful stakeholder engagement and participation. Among the opportunities for stakeholders to engage in Regional Review processes and activities are the following activities. These will be complemented by preparatory and thematic consultations at the sub-regional level:
  - [October 2023- December 2024] At least twelve weeks prior to each Regional Review, **one virtual stakeholder pre-consultation for each region** would be organized in order to draw inputs early enough to inform the inter-governmental Review meeting discussions and the agenda of the Multi-stakeholder Consultation. The pre-consultations would focus on both: a) substantive feedback on thematic priorities, b) recommendations for a robust regional stakeholder engagement process for the Reviews, and c) recommendations for selecting a stakeholder rapporteur. The rapporteur will present a summary of the Multi-stakeholder consultations in the Regional Review meeting and this will be posted online.
  - [March 2024- March 2025] The Network will support the organization of **one in-person continental Multi-stakeholder Consultation for each region**, complemented where feasible, by preparatory consultations at the sub-regional level. In order to maximize in-person interaction

among stakeholders, Member States and UN entities, the multi-stakeholder consultation could be organized one day prior to the review meeting, subject to feedback and inputs received by stakeholders on the organizational aspects.

- All stakeholder consultations will provide interpretation in relevant UN languages and the Network will disseminate relevant materials well in advance of any meetings.
  - The Network will ensure that there is diversity of stakeholders represented, including by sub-regions, and migrant and youth representatives, among others.
  - **Migration Network Hub – Discussion Spaces:** In January 2024, the Network will launch five [discussion spaces](#), one for each region, on the [Migration Network Hub](#). The discussion spaces will be a place where stakeholders may continually post feedback, recommendations, data, and reports on the implementation of GCM objectives and migration policy. An analysis paper of submissions for each regional Discussion Space will be presented prior to each Regional Review.
  - **GCM Talks:** Stakeholders are encouraged to participate in and co-organize activities as part of the preparatory process including the “[GCM Talks](#)” and side events at country, sub-regional, regional or global levels. GCM Talks and other preparatory consultations may be co-organized by Member States, stakeholders, and Network members as peer-learning exchanges to continue discussions on how best to implement the GCM and to highlight sector-specific or thematic priorities.

## II. REGIONAL NETWORK PRESENTATIONS

### African Region

- *Key aspects of the second Africa GCM Regional Review*
  - The Regional Review is scheduled for early October 2024. Prior to the review meeting a series of multi-stakeholder consultations and engagement with stakeholders and civil society, including youth groups, will be organized by UNECA, together with partners AUC and the UN Network for Africa.
  - Leading up to the second round of Regional Reviews, the aim is to build and formalise a continental GCM list of civil society organizations and stakeholders and to ensure their feedback into the Regional Reviews.
  - The upcoming Review in Africa will focus on subregional engagement, GCM implementation initiatives and highlight activities and strategies at the level of RECs and Regional Consultative Processes (RCPs).
  - A draft roadmap for the Africa Regional Review will soon be shared.
- *Plans for stakeholder engagement in Africa Regional Review process*
  - The workplan for 2023-2024 for the Regional Network for West and Central Africa, aimed at supporting the GCM implementation of Member States in the region, has been adopted and will soon be accessible on the UN Network Migration website [here](#).

- Stakeholders from the West and Central African region have supported the drafting of this workplan through a stakeholder consultation held in May 2023.
- Within the workplan, there exists a dedicated workstream co-chaired by ILO and OHCHR for stakeholder engagement. Stakeholders from the West and Central African region are encouraged to actively participate in this workstream and can contact [cgaspar@iom.int](mailto:cgaspar@iom.int).
- The African Regional Network on Migration welcomes stakeholder participation in all thematic workstreams. These include climate change on migration, free movement (especially regarding the youth), legal identity and labor migration, reintegration and returnees, data, missing migrants, and remittances. Stakeholders working on these issues in the region are highly encouraged to engage.
- Regarding the Regional Reviews, there are two RECs in our region; Economic Community of West African States (ECOWAS) and the Economic Community of Central African States (ECCAS).
- Prior to the Regional Review in October 2024, there will be sub-regional consultations planned for spring 2024 with ECOWAS and ECCAS. The workplan includes a dedicated workstream focusing on this aspect, and stakeholders are encouraged to actively participate in these discussions to provide feedback and inputs.
- Dedicated pre-consultations with stakeholders are scheduled to take place, culminating in a report that highlights the outcomes of these discussions. This report will feed into the multistakeholder consultation. A stakeholder Rapporteur will then convey the outcomes of the multi-stakeholder consultation at the opening of the intergovernmental meeting.

***Europe (including Central Asia and North America)***

- ***Key aspects of the second Europe GCM Regional Review***

- The UNECE regional network has supported the establishment of 15 country UN Networks in the region, each co-chaired by the UN Resident Coordinator and IOM.
- The GCM Regional Review meeting for Europe is scheduled to take place as a one-day meeting on 11 March 2024, back-to-back with the Regional Forum on Sustainable Development for the ECE region. This shows the strong interconnection between the GCM and Agenda 2030.
- The Regional Review will focus on how Member States and stakeholders in the region collaborate to advance the implementation of the GCM. Discussions will highlight both successes and challenges in such collaboration, as well as address instances where collaboration is evidently needed.
- In line with the overall framework in the UNECE region, the Regional Review will enable governments to assess GCM implementation progress, regional challenges, and the outcomes of the 2022 IMRF. Discussions will also delve into existing initiatives and experiences aimed at strengthening linkages between GCM and the 2030 Agenda.
- The second round of Regional Reviews will also serve as a forum to strengthen regional cooperation on migration and contribute to the formulation of recommendations for the 2026 IMRF.
- In line with the 360-degree vision of the GCM, Regional Review meeting will be organised around four thematic roundtables, akin to the previous Regional Review. Member States and stakeholders will be

invited to take the floor during each thematic roundtable discussions.

- ***Plans for stakeholder engagement in the Europe GCM Regional Review***

- To support Member States and Stakeholders in their preparations for the Regional Review, a series of questions is being developed to guide the discussions.
- A pre-consultation meeting with Member States took place on 18 October 2023, and a pre-consultation with stakeholders is scheduled for 14 November 2023.

- Two GCM talks have already been held in the UNECE region:
  - [Migration and adaptation in the context of climate change](#), co-hosted by the United Kingdom's Foreign, Commonwealth and Development Office (FCDO) and IOM UK along with the participation of stakeholder groups based in the United Kingdom. Speakers explored ways in which migrants can be part of the solution if included in adaptation, planning, implementation, and monitoring.
  - [Capitalizing on Human Mobility for the Advancement of Regional Cooperation and the Development of Our Societies](#), held back-to-back with the Almaty process, saw the participation of Member States, UN agencies, and civil society organizations and stakeholder groups.
- A multistakeholder consultation for the UNECE region will precede the intergovernmental meeting. The purpose of this consultation is to identify priorities, areas, and prepare key messages. It will be held before 11 March and will take place in a hybrid format. Stakeholders must register for either online or offline participation following UNECE procedures. Further details will be shared by the UN Network on Migration.
- An open call for expressions of interest for the stakeholder Rapporteur will be initiated. Stakeholders interested in the role of Rapporteur for the Europe region can contact [mignetUNECE@iom.int](mailto:mignetUNECE@iom.int).
- The stakeholder Rapporteur's responsibilities will include briefing Member States on the findings of the stakeholder consultations at the opening of the intergovernmental meeting.

### ***Latin America and Caribbean (including North America)***

- ***Key aspects of the second Latin American and Caribbean GCM Regional Review***

- A regional pledge has been established to organize a debate forum among different participating organizations and representatives from the Latin American and Caribbean regions.
- The United Nations Network on Migration in Latin America and the Caribbean organized on 8 August 2023 the [First Forum of the Civil Society Dialogue Mechanism](#) within the framework of the GCM in

Panama. The Forum focused on reducing vulnerabilities in migration and the socioeconomic integration of migrants, two priority topics for the region.

- A report on the meeting, along with a briefing note and a recording, will be published to disseminate the main outcomes and raise awareness about identified priorities between government representatives, civil society organizations and stakeholders.
- The Regional Review is scheduled to take place in November 2024 in Santiago, Chile, back-to-back with the Regional Conference on Population and Development in Latin America and the Caribbean.
- The purpose of the Meeting is to provide a common platform where Member States and all stakeholders can contribute to the debate on the challenges, progress and needs in the implementation of the GCM in the region. All ECLAC Member States, civil society and stakeholders are encouraged to participate.
- The structure of the Regional Review has been outlined in a roadmap aligned with the 2023-2024 workplan, which identifies key priorities and thematic areas. The workplan is available in [English](#) and [Spanish](#), and the roadmap will soon be published on the UN Network on Migration website [here](#).
- The roadmap includes a list of actions and activities leading up to the Regional Review, including engaging with the “[GCM Talks](#).”
- In line with the whole-of government and whole-of society approach to the GCM, a pre-consultation meeting with Member States and a pre-consultation meeting with stakeholders is scheduled for mid - 2024, focusing on exchanging best practices to promote pledges in the region.
- In addition, a multi-stakeholder consultation with regional consultative processes will precede the intergovernmental meeting in November 2024. These discussions will provide inputs and feedback for the 2026 IMRF.
- The Economic Commission for Latin America and the Caribbean (ECLAC) will continue supporting the works of regional Networks to further assist Member States and stakeholders in the region. Promotion of increased engagement with stakeholders and civil society organizations, as well as support for their work and the organization of joint activities, remains a priority.

### ***Asia-Pacific Region***

- ***Key aspects of the second Asia-Pacific GCM Regional Review***

- The intergovernmental meeting for the Asia-Pacific region is scheduled for the first quarter of 2025. Dates for intergovernmental meetings are established through consultation with Member States. Additionally, holding the meeting closer to the 2026 IMRF ensures that outcomes will directly feed into the IMRF.
- The structure of the intergovernmental meeting adheres to the Economic and Social Commission for Asia and the Pacific (ESCAP) rules of procedure and aligns with the whole-of-government and whole-of-society approach of the GCM. This approach involves bringing in civil society organizations and stakeholders to participate and engage in the meeting.



- Active partners within the regional UN Network, including ILO, IOM, OHCHR, UNDP, and UNICEF, serve as core members. Observers, such as UNESCO, UNFPA, UNODC, and UN Women also contribute to the process.
- Starting in January/February 2024, regular meetings are scheduled, most likely on a monthly basis, to meet and prepare for the Regional Review process. A concept note is being prepared, and dates will be shared once they are set.
- ***Main activities planned for the second Asia-Pacific GCM Regional Review***
  - The Asia-Pacific region will leverage the mapping of progress and challenges of IMRF pledges, Chair’s summary, statements, surveys of first round of GCM Regional Review, IMRF Progress Declaration, and GCM to identify themes and priorities raised by Member States, civil society organizations, and stakeholders.
  - Together with the UN Network members, the drafting of the migration report, a cornerstone of the review process, will be undertaken. It’s anticipated launch by the end of 2024 will likely focus on the GCM clusters and provide an evidence-based approach to the Regional Review.
  - In emphasizing the importance of stakeholder engagement, considerations include the creation of an information paper to support this emphasis, aiming to provide recommendations at the intergovernmental meeting.
  - Efforts are being made to use the database that includes all stakeholder and civil society organizations involved in the first round of the Asia-Pacific Regional Review. Engagement is sought not only for the intergovernmental meeting but also throughout the entire preparatory process starting next year.
  - Stakeholders in the Asia-Pacific region are encouraged to submit requests to organize GCM talks [here](#).
  - Consultation meetings with governments will be organized, alongside separate tracks for consultations with stakeholders and civil society organizations.
  - Regional Network Members in the Asia-Pacific aim to contribute to the Secretary-General’s report, due in 2024, to ensure recognition of the Asia-Pacific Review at the 2026 IMRF and influence global discussions.
- ***Roadmap Stakeholder Consultation***
  - Consultations with stakeholders will begin in January/February 2024.
  - Outcomes and key recommendations will feed into the intergovernmental meeting roundtables by stakeholder Rapporteurs.
  - A summary consultation will likely be scheduled prior to the intergovernmental meeting. Depending on the availability of resources, this could be in a hybrid format.
  - UN Network members from the Asia-Pacific region suggest aligning the Regional Review process with the Asia-Pacific Forum on Sustainable Development in 2024. This forum will focus on the sustainable development goals, which the GCM is rooted in.

- A sub-regional consultation is scheduled to take place in Bangkok, Thailand, on 6 and 7 November, focusing on SDG 16 in relation to migration. Further arrangements for similar events leading up to the intergovernmental meeting in 2025 are under discussion.
- ***Stakeholder engagement and capacity development***
  - To enhance the capacities of UN Country Teams and Stakeholders to integrate the GCM into day-to-day practices, UNNM has piloted capacity development work development workshop.
  - Thus far one workshop was held in Cambodia primarily with the UNCT.
  - A second workshop in Bangladesh will have a focus on stakeholders in what would be an innovative practice to further crowd in stakeholder engagement in a truly whole of society manner.
  - ESCAP and UNFOA are organizing the Seventh Asian and Pacific Population Conference (APPC) to be held in Bangkok and online from 15 to 17 November. From 13 to 14 November, a CSO Forum and Youth Forum will be held, feeding into the 7th APPC. Civil society organizations and stakeholders working on migration have applied to participate.

### ***Middle East-North Africa (MENA) Region***

- ***Roadmap for Regional Reviews in the Arab region***
  - The Regional Review meeting is expected to be held in the second quarter of 2024, between mid-May and mid-June.
  - A roadmap for the calendar and preparation of the Arab Regional Review process is available [here](#).
  - The Regional Review will be organized by IOM, ESCWA, and the League of Arab States, in collaboration with the members of the Regional UN Network on Migration in the region, and with the support of the Secretariat of the UN Network on Migration. The Review will serve as the culmination of all the national, sub- and cross-regional discussions hosted by Member States and the Regional Consultative Processes (RCPs) as well as the Regional and National UN Network members and stakeholders in the region.
  - The workstreams launched under the Regional UN Network on Migration will support the preparatory process for regional review process by organizing a series of dialogues, the GCM Talks series, that will feed into the Regional Review. This will be done for the following workstreams:
    - Alternatives to Detention and Deprivation of Liberty in July 2023
    - Climate Change, the GCM and the Paris Agreement in September 2023
    - Enhancing pathways for regular migration through bilateral labor agreement in November 2023
  - The GCM Talks will also help to map existing practices, identify gaps in implementation and emerging challenges at the regional and cross-regional level.
  - The regional Network with support from the regional Stakeholder Advisory Group and the secretariat of the UN Network on Migration will host one regional multi-stakeholder consultation



prior to the Regional Review.

- North Africa and other Arab-Africa Member States are invited to participate both in the Regional Review in the MENA region and in the Africa Review scheduled in 2024.
- Building on the momentum from the first GCM Regional Review process and its findings, the second Regional Review process will offer an opportunity for Member States and stakeholders in the region to:
  - Critically reflect on intra-regional and cross regional priorities, emerging issues, and gaps in the implementation of the GCM.
  - Identify regional progress and challenges in implementing the recommended actions set out in the IMRF Progress Declaration.
  - Consolidate critical findings and recommendations to inform the 2026 IMRF.
  - Highlight good practices and exchange experiences to accelerate the achievement of the GCM objectives.
  - Explore opportunities for strengthening regional and cross-regional cooperation on migration.
- The process will result in the production of summary reports of regional review meetings and an Outcome Document of the Regional Review that will summarize the key messages from all participants. It will also include an annex of key messages from the stakeholder consultation(s). The Outcome Document should be finalized by September 2024, and will be considered at the plenary meeting of the General Assembly in the second half of 2024 to be presented by the Coordinator of the Network

### **III. SUMMARY OF STAKEHOLDER AND CIVIL SOCIETY INPUTS**

- *Key thematic priorities and emerging issues*

- Stakeholders at regional and national levels emphasized the need to engage with all 12 stakeholder sectors named in the GCM in an equitable way by UN Network. This includes migrants, civil society, migrant and diaspora organizations, faith -based organizations, local authorities and communities, the private sector, trade unions, parliamentarians, national human rights institutions, the International Red Cross and Red Crescent Movement, academia, the media.
- Stakeholders have highlighted key thematic priorities and emerging issues that are of significance for their regions and sectors in the lead up to the second round of Regional Reviews. Some of the priorities and emerging issues include, but are not limited to:
  - Implementation of measures oriented towards ensuring the protection of migrants from a human rights perspective;
  - Safeguarding the rights of migrant domestic workers, ensuring fair recruitment, access to justice, freedom of movement, freedom of association to join trade unions and migrant associations and social security;
  - Enhancing collaboration on labor rights and the involvement of trade unions,
  - Protecting from shrinking civic space overall and specifically for informal migrant workers, specifically domestic workers, who face threats for participation;
  - Highlight the thematic needs and contributions of migrant community-led organizations in GCM implementation and partnerships;

- Encourage further participation and identify thematic key messages of migrant rights groups and migrant-led organizations, especially women's groups;
  - Exploring gaps in the application of the Guiding Principles of the GCM, namely on comprehensive and measurable whole-of-society approach. For instance, balancing government reports with civil society perspectives is called for.
  - Emphasizing the importance of inclusivity in terms of accessibility to venues as and the development of materials in regional languages to ensure broader participation and engagement.
- Both consultations underscored the significance of connecting governance levels from local to global, emphasizing the link between local governments and national and global discussions.
  - Participants anticipate a busy year with multiple upcoming consultations, aiming for action-oriented discussions.

- ***Process***

- Stakeholders at regional and national levels raised questions about the process of ensuring that multi-stakeholder inputs reach the General Assembly and how to guarantee the General Assembly's reception and consideration of these inputs.
- Questions raised include: How many stakeholders can participate in each Regional Review meeting? How can the Network increase interaction between governments and stakeholders? How are the summaries from stakeholder consultations utilized and where do these inputs go? And finally, how are rapporteurs chosen?
- Stakeholders raised questions about how to get more engaged with Regional and Country level UN Networks and the need to receive more regular information about opportunities to contribute the Regional Reviews and ongoing work at the national and country level.
- Stakeholders at regional and national levels also emphasized the importance of considering logistical issues related to the ability and accessibility to participate in venues for the Regional Reviews.
- Stakeholders emphasized on the need to recognize the limits to access to information by addressing challenges posed by the digital divide, language barriers, and the timely distribution of materials and information regarding meetings/ consultations and opportunities for contribution.
- Stakeholders shared the importance to have a transparent and open selection process for selecting the rapporteur team responsible for summarizing discussions, particularly regarding the potential participation of civil society members.
- Stakeholders at regional and national levels advocated for active involvement in regional consultations, underlining the necessity for extended opportunities to engage with Member States during these consultations, rather than treating them as separate debates.
- Stakeholders in the Africa region emphasized their willingness to actively participate in various thematic workstreams, such as climate change, migration, free movement, legal identity, labor migration, reintegration of returnees, data, migrant domestic workers, missing migrants, and remittances.

- They also recommended that these organizations should encourage governments, particularly in the Asia-Pacific and Arab region to involve unions in migration policy discussions using social dialogue and national tripartite mechanisms.
- Stakeholders in the UNECE region expressed the importance of including parliamentarians and mayors with all stakeholders during consultations.
- Stakeholders in the MENA region stressed the need to recognize the limits in implementing a whole-of-society approach to migration issues and therefore to discuss strategies to counter these limits, through increased participation of migrant groups, particularly women migrant groups at regional and national levels.
- Stakeholders highlighted the importance of creating safe and brave spaces, especially for migrant domestic workers who particularly face threats in the Arab and Asia-Pacific regions for participating in the Network’s activities and processes or for joining regional and national trade union networks.
- There was a strong call to meaningfully engage with migrant communities, trade unions, and National Human Rights Institutions. Questions were raised regarding the Network’s strategies to ensure the participation of these groups and the sharing of information with them.
- Additionally, a call was made for regional and national Networks to develop strategies aimed at enhancing their outreach to stakeholder and civil society organizations.
- Stakeholders in the UNECE region stressed the importance of language inclusivity in Regional Reviews, particularly emphasizing the need for Russian interpretation in the UNECE Regional meeting.
- Stakeholders in UNECE region suggested that North America should be included in the Latin America and the Caribbean Regional Review, and that this inclusion should be explicitly be stated in upcoming regional consultations.
- Stakeholders at regional and national levels requested clarity in announcements and titles of Regional Reviews to specify the included regions, such as Central Asia in both Europe and Asia reviews.
