#### Introduction

Facilitated by the Coordinator of the United Nations Network on Migration, the International Migration Review Forum will include a policy debate<sup>1</sup>, which will focus on the challenges in the implementation of the Global Compact on Safe, Orderly and Regular Migration (Compact), including links with the 2030 Agenda for Sustainable Development, the capacity-building mechanism and contemporary and emerging issues related to migration.

The policy debate will also consider possible guidance for the United Nations system to strengthen its efforts in improving system-wide effectiveness and coherence and in supporting Member States in implementing the Global Compact, upon the request of Member States, based on their national policies and priorities.

The debate will take place on the second day of the IMRF, 18 May 2022, 3:00-6:00 PM, EST.

The Network will host a webinar to support Member States and other relevant stakeholders in preparing for this policy debate. This webinar aims to offer an open and inclusive space where Member States and all other relevant stakeholders can highlight and exchange perspectives on the most pressing contemporary and emerging issues related to migration, and towards the implementation of the Compact. This webinar will provide inspiration for the background note for the policy debate, as well as for its organization. The background note will be finalized by the end of April 2022.

This webinar is part of the <u>Network's Migration Dialogues series</u>. As part of the series and to ensure meaningful and lasting interactions between participants, speakers and Network members in preparation of the policy debate, the Network has created <u>a dedicated discussion space</u> on the Migration Network Hub where participants can ask questions and share recommendations ahead, during and after the Dialogue.
